INSPECTION REPORT OF GOVERNMENT COLLEGE
BIROHAR (JHAJJAR)

Reference Endst No. CB-1/2019/F-178/9028 Dated 12/04/19

Inspection Committee comprising Professors Jaibir S. Hooda and K. V. Chamar visited the college on 04 May 2019 to inspect the college for grant of One (01) additional Unit for B. A. - II and continuation of provisional affiliation for One (01) additional Unit for B.A. - I with an intake of 80 students in each Unit for the session 2019-20.

Observations and recommendations of the committee are:

OSERVATIONS

1. The college has enough rooms, furniture and other physical infrastructure for the increased number of students.
2. Faculty is short and the college needs to get required number of teachers before the beginning of the classes: 03 in English; 01 in Hindi; and 01 in Geography.
3. The college could not provide record of the compliance of the recommendations of the Inspection committee which visited the college on 23/10/2018.
4. The college does not have well laid play grounds but it has lot of land and needs to develop grounds for regular use.

RECOMMENDATIONS

The college may be granted provisional affiliation for an additional Unit for B. A. 2nd year and its continuation in B. A. 1st year for the session 2019-20 with an intake of 80 students in each Unit. The University must ensure that the college makes up for the shortage of faculty.

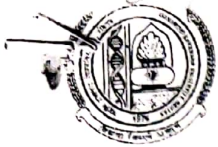
